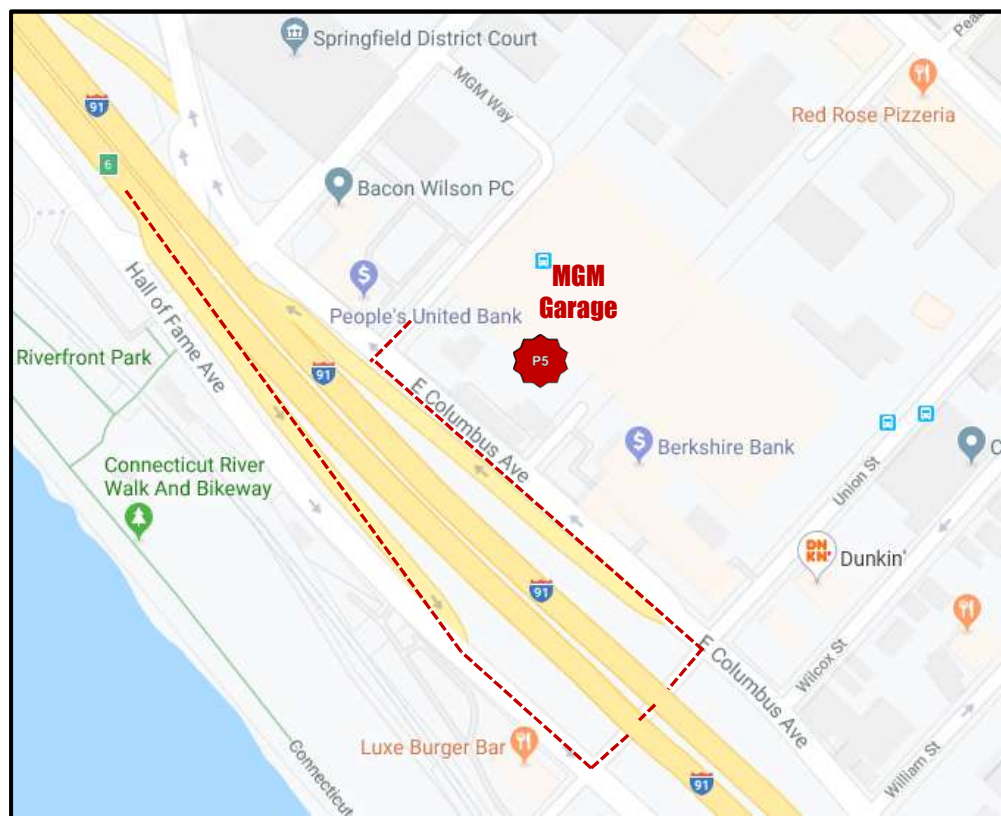

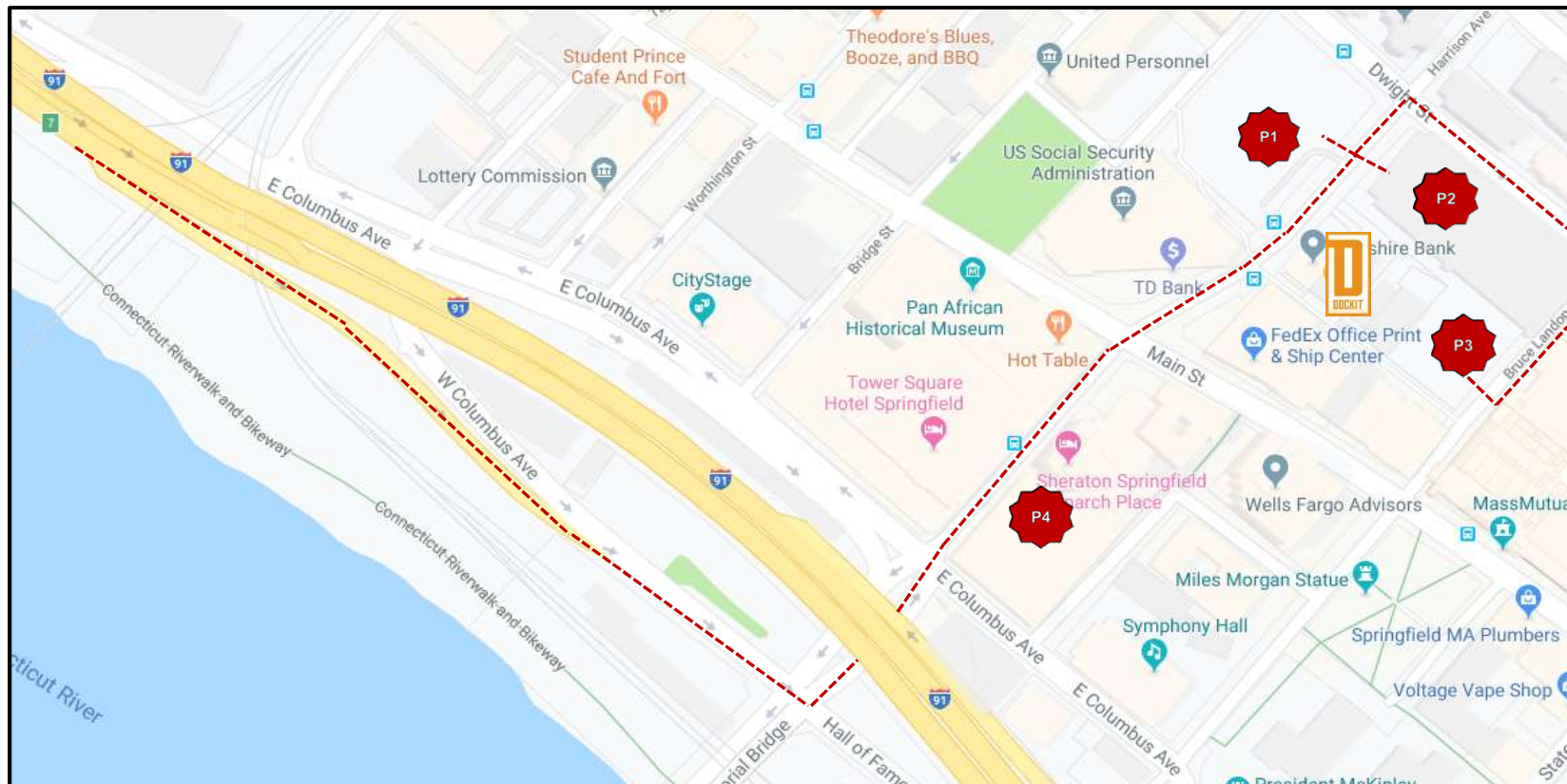

1. Exit 7, Hall of Fame Avenue – Downtown Springfield
2. Left at light onto center lane of Borland Way, pass under highway
3. After crossing E. Columbus Ave., stay in left lane unless turning right into [P4] Sheraton Parking
4. Continue straight onto Harrison Ave for [P1] TD Bank lot and [P2] Civic Center Garage
5. Right on Dwight then first right onto Bruce Landon for [P3] Pro-Park lot

4. Watch for **[P5]** MGM Parking entrance on right (Fig. 2)

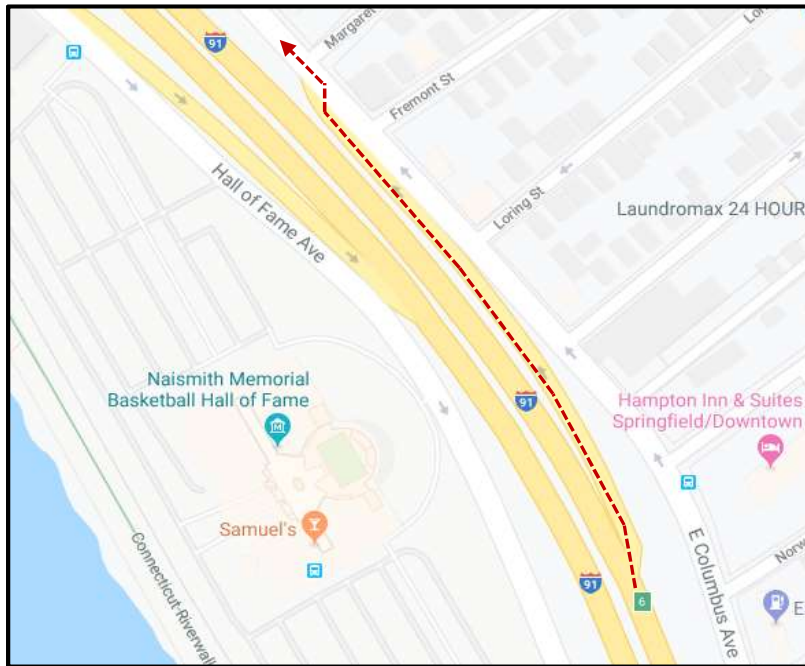

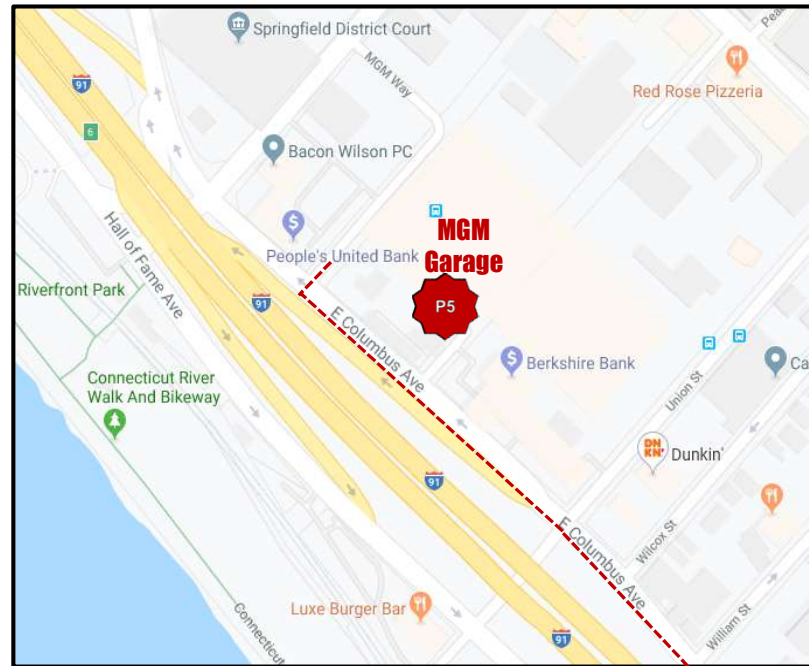

4. Pass under the Sheraton pedestrian bridge and turn right onto Borland Way (Fig. 2)
5. Get in left lane unless turning right into [P4] Sheraton Parking

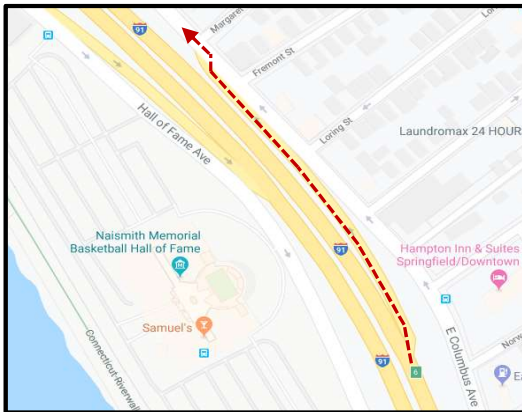

7. Right on Dwight then first right onto Bruce Landon for [P3] Pro-Park lot

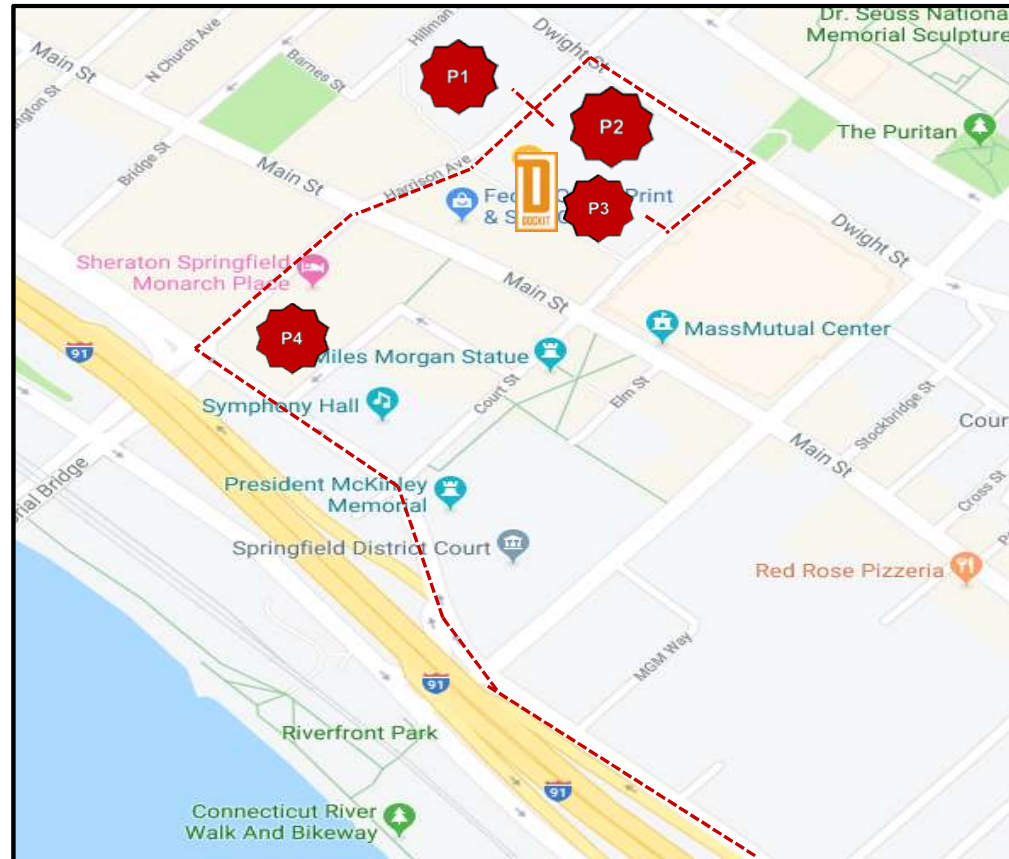
